New Business

1. Preliminaries

- a. Call Meeting to Order - Mr. Delfino called the meeting to order at 5:30.

2. **Approval of Minutes from 8.17.2021** - Mr. Murphy made a motion to approve the minutes, Ms. Vaillancourt seconded the motion and it passed 3-0.

3. **Vouchers to be Approved** - Ms. Vaillancourt motioned to approve the vouchers, Mr. Murphy seconded and it passed 3-0.

4. **Septic Variance Request**

- a. 11 Temple Ave. – Ms. Calo stated that the engineer is requesting their SAS to be 10 feet from the house vs. 20 feet due to space restrictions. Mr. Delfino approved variance request. Mr. Murphy motioned to accept the variance as presented, Ms. Vaillancourt seconded and it passed 3-0.

5. **Community Social Worker**

- a. Appointment of Alexandria O'Hare - Ms. O'Hare joins us from Advocates and has worked with the Hudson Senior Center in the past. Alex's start date is

7. **Maynard Intermunicipal Agreement Update** – Ms. Calo informed the Board that the agreement will end on Sept 13, 2021 and will not extend. Ms. Calo will assist the Maynard's Assistant Town Administrator as needed.
8. **COVID-19 Update** - Ms. Calo informed the Board that our Public Health Nurse has been working with school nurses on new cases. This week there are 35 new cases, the previous week there were 36 cases.

Mr. Murphy motioned to require all persons entering Town of Hudson municipal buildings to wear a face covering (*medical exemptions apply), Ms. Vaillancourt seconded and it passed 3-0. This will not be a town wide mask mandate. The mask mandate will start on Monday Sept. 20th, 2021.
