New Business

1. Preliminaries

- a. Call Meeting to Order Mr. Delfino called the meeting to order at 5:30.
- Approval of Minutes from 3.15.2022 Ms. Monteiro motioned to approve minutes, Ms.
 Vaillancourt seconded the motion and it passed 3-0.
- **3. Vouchers to be approved** Ms. Vaillancourt motioned to approve the vouchers, Ms. Monteiro seconded the motion and it passed 3-0.

4. Housing

- **46 Bennett Street** – Mr. St. Louis informed the Board of the trash issue outside the residence. In collaboration with a few other town departments, a clean-up service (PuroClean) was contracted to facilitate the clean- up. Mr. St. Louis presented before and after pictures of the property to show progress of the clean-up. The residents are receptive to help and Mr. St. Louis

will continue to work with them and monitor their progress. The residents are currently signed up for trash service through a private hauler.

-22 Lakeside Ave – Mr. St. Louis informed the Board that 22 and 24 Lakeside Ave have a combined septic field and septic tank for 22 Lakeside has been overflowing for years. Mr. St. Louis has been working with the owner to have the system upgraded and has provided her resources from the State. Mr. St. Louis has issued an order to abate. Mr. Delfino is concerned about the sewage going in to the lake and suggested weekly pumping. If the owner cannot comply, the system will be declared unusable. The owner has one month to comply.

- 5. **COVID-19 Update** Mr. St. Louis informed the Board last month there were 35 cases. As of April 12 there are 29 cases.
- 6. Hudson Health Fair Update Mr. St. Louis informed the Board that Health Fair was held on April 7th at Hudson High School. Approximately 30 MA Health applications were completed and Edward M. Kennedy provided Covid vaccines (12 Pfizer, 6 Moderna). Ms. Vaillancourt inquired if varicella or DTaP vaccines were given. Mr. St. Louis was not sure if those vaccines were administered.
