# Minutes of Meeting – October 23, 2019

The <u>Hudson Commission on Disabilities</u> met at the Town Hall, 78 Main Street, Hudson, Massachusetts.

At 10:00AM, Jack Hunter called the meeting to order.

#### Welcome and Introductions

Mr. Hunter welcomed everyone to the initial meeting of the Commission on Disabilities in Hudson. He reviewed the activities he has been working on since his tenure in Hudson in 2015 and was delighted to be here.

Each member, including Ms. Johnson told their story and why they wanted to serve on the Commission.

## Review of MGL 40 Sec 8J; draft mission statement; grievance policy; transition plan and survey and self-evaluation

Ms. Erickson asked Mr. Hunter to review these documents. Mr. Hunter went through MGL 40S 8J and read its contents. He then explained how he had previously drafted a Mission Statement and was now looking for endorsement by the COD. Mr. Noyes volunteered to take a look a t the draft and come back with his comments. Mr. Hunter next handed out the Towns existing grievance policy which outlines a step by step process for anyone who wished to file a grievance. Lastly, Mr. Hunter reviewed a completed Survey and Inventory of every Town

owned property and building including a transition plan. He noted that he has applied to the State for funding to complete all the listed improvements in the plan.

## **Other Business**

Lastly, they discussed having guests speakers at future meetings such as State officials; BID representative; Police and DPW.
