Minutes of Meeting – December 14, 2021

Pursuant to the Chapter 20 of the Acts of 2021 Suspending Certain Provisions of the Open Meeting Law, G.L. c. 30A, §18, this meeting of the <u>Hudson Commission on Disabilities</u> was conducted via remote participation.

Welcome from the Chair

Ms. Andrea Erickson welcomed everyone to the meeting.

Planning Department project updates and Town Meeting updates

Tom Green provided an update on the creation of the Hudson Bike-Pedestrian Committee, and asked if any Commission on Disability members would be interested in serving as a representative on the Committee. Mr. Green and the Commission discussed the potential time commitment, and identified some locations in Town that have accessibility issues. Mr. Frank Noyes expressed interest in serving as a COD representative on the Committee, and asked that Mr. Green submit his name to the Select Board for consideration.

Ms. Molina Dumas provided Planning Department project updates. The proposed Zoning Amendment was voted down at Town Meeting, meaning there will be no changes to the Zoning By-Laws for the time being. The Zoning Board of Appeals approved a Comprehensive Permit for the Affordable Housing project located at 62 Packard Street, which includes 5 accessible units.

The Commission reviewed the proposed 2022 meeting schedule and discussed what time of day they would like to meet, deciding on 9:30 AM. The Commission voted to approve the 2022 meting schedule. 3-0-0. Unanimous.

Discussion of potential new commission members

The Commission discussed the qualifications of each candidate, agreeing that each would be a good fit for the Commission.

The Commission voted to recommend Sheryl Marrazzo and George Luoto to the Select Board for the vacant COD positions. 3-0-0. Unanimous.
