Ms. Molina Dumas provided an update on the scheduling of local guest speakers and disability advocate speakers from the Massachusetts Office of Disability (MOD), and hopes to have one scheduled for the next COD meeting. Ms. Molina Dumas also shared upcoming free virtual workshops being offered by the MOD and how to register. Mr. Noyes mentioned completing Community Access Monitor training in the past, which was helpful in understanding residential vs. commercial requirements for accessibility.
