### Meeting Minutes July 26, 2022

Pursuant to Governor Baker's March 12, 2020 Order Suspending Certain Provisions of the Open Meeting Law, G.L. c. 30A, §18, and the Governor's March 15, 2020 Order imposing strict limitation on the number of people that may gather in one place, this meeting of the Hudson Commission on Disabilities was conducted via remote participation.

Guest Speaker, Steven Santos, Director of Recreation, Town of Hudson

Steven Santos discussed Town projects including Centennial Beach and Town parks. George Luoto asked about the possibility of providing access to the caboose on the ARRT, and about the need for an accessible kayak launch. He suggested the Armory as a possible location for the kayak launch. Steven Santos thanked the Commission for their suggestions and said he will include the Commissioners in future planning activities by the Recreation Division.

#### Hudson Bike and Pedestrian Committee update

Frank Noyes reported that over 600 responses to the Bike and Ped survey have been received and there is a huge amount of data that is being sorted and analyzed. Three Community Forums will be scheduled to give residents additional opportunities to participate.

#### Other Business

- Home Modification Loan Program Amanda Dumas reported that she had handouts from the program and planned to distill it down to key information and distribute to the Commissioners. Sheryl Marrazzo said she had used the application and that it required a huge amount of information to be entered.
- Building Inspections Andrea Erickson said she recently had difficulties with an inspection for her deck and asked if there were inspections specific to ADA compliance.
   Frank Noyes said that the Building Inspector was concerned with meeting building codes but not with ADA compliance.
