## Public Hearings

## 77 Cherry Street, continued NOI, 190-0635

## Present: David Cowell, Hancock Associates; Xiaofeng Yan. Hudson Light and Power; Jonathan Moore (Licensed Site Professional)

Hancock Associates has been brought in to handle the project. They will be surveying the site, measuring elevations and flagging resource areas. They will respond to Commission and DEP information requests.

Paul Byrne expressed concern about fuel escaping from the tanks if precipitation gets between the walls and requested that a sheet metal roof be constructed over the tanks for safety. Xiaofeng Yan said that DEP does not require containment for double walled tanks. David Cowell will obtain the detailed specifications for the tanks and continue discussion at the next meeting.

Jonathan Moore confirmed that soils from the area tested positive for low levels of petroleum and need to be kept in a place that has similar or higher levels of contamination. No further soil disturbance is expected unless flood plain calculations require that compensatory flood storage is provided. Jonathan Moore also confirmed that current soil containment including straw wattles and plastic tarp should be sufficient to protect the river from contamination.

Paul Byrne moved to continue the hearing to August 15 at 7:00. Second by Joe Rodrigues, vote 6-0-0.
