Meeting Minutes June 4, 2020

Pursuant to Governor Baker's March 12, 2020 Order Suspending Certain Provisions of the Open Meeting Law, G.L. c. 30A, §18, and the Governor's March 15, 2020 Order imposing strict limitation on the number of people that may gather in one place, this meeting of the Hudson Conservation Commission was conducted via remote participation.

The applicant proposes to construct a raised deck at the back of her house in Outer Riverfront to the Assabet River. The lot is flat and the posts will be dug by hand. The Commission had a site visit after the last hearing. They agreed that there would be less disturbance if the soil was removed from the opposite side of the berm than the side originally discussed. Heidi Graf said the work should be permitted with an NOI due to soil and tree disturbance in Riverfront Area. She thinks the alteration should be stabilized to be permanent so that future access to the yard is possible without further disturbance. Emilie Wilder suggested finding an alternate way to do the work with smaller equipment that could be brought in from the front of the house. Brandon Parker expressed concern about installing erosion control and

possibly disturbing soil beyond the property line. David Mercer suggested measuring the property based on the plot map provided by the Town to determine the property boundary.
