Minutes Approval

On a motion by Ms. Vineyard to amend the minutes replacing

seconded by Mr. McNealy, the Committee voted 8-0-0 to approve the meeting minutes of September 12, 2023 as amended.

Committee Prior Business and Priorities Status Review

1) Developing minimum requirements from requesters and sponsors for the Committee to review budget requests and Warrant articles, respectively (SC);

This document is a work in progress and will be updated through the FY25 budget review.

2) Designating "Debt Management Subcommittee" related to capital requests (JM);

Mr. Vaidya has provided a report of the town's current debt obligations with projections for the next 10 years. That report will be updated annually or as needed and can be referenced to assess impact as debt warrant articles are considered. The report will be referred to as the **10 Year Debt Service Schedule.**

3) MA DOR DLS Bureau of Accounts Statement of Indebtedness (SC)

The statement can be made available but the 10 Year Debt Service Schedule will meet the requirement.

New Business

1) Committee designee to "DPW Building Committee" (SC)

The Select Board authorized the creation of a DPW Building Committee requesting a representative from the Finance Committee.

On a motion by Chair Calandra seconded by Mr. Beaudette the Committee voted 8-0-0 to approve Mr. Fiorello as the DPW Building Committee representative with Mr. McNealy as an alternate.

2) Warrant Article Hearings (see schedule below)

Article 1 Prior Years Bills

Mr. Gregory reported that no bills have been received as of this date.

On a motion by Ms. Jagling seconded by Mr. Forti the Committee voted 8-0-0 to Pass Over Article 1.

Article 2 Transfer of Funds to Purchase Police Radio System

Town Meeting must approve interdepartmental budget transfers that do not occur at year end. Chief Johannes explained that a transfer was made in November 2022 from the radio account balance to support the acquisition of security cameras. This transfer returns an unused amount to the radio account to replace radios that are no longer supported.

On a motion by Mr. Forti, seconded by Mr. Beaudette Article 2 the Committee voted 8-0-0 to Recommend Article 2.

This article was tabled to be reviewed at the next Finance Committee meeting.

Article 4 Transfer from Stabilization Fund, Municipal Finance Software

Mr. Vaidya described the town's current use of 7 disparate and unintegrated programs for financial management. This lack of integration drives many labor intensive operations including posting operations that delay access to real time financial data. The purchase and implementation of an Enterprise Resource Planning (ERP) system will facilitate reporting and integration of data across departments, reducing labor intensive processes and making real time accurate data available.

Migration to an ERP will be a long process. Allocating \$1,210,000 from the Stabilization Fund allows this process to begin. The funds allocated from Stabilization will be restored from Free Cash at the end of FY24. This allocation will cover costs for the next 18 months.

A transfer from the Stabilization Fund requires a 3/3 vote at Town Meeting.

On a motion by Mr. McNealy seconded by Mr. Forti the Committee voted 7-0-1 to Recommend Article 4.

Article 7 Amend General Bylaws, Board of Health

Ms. Antonelli explained that this bylaw change brings the town in to compliance with state law. The legal age to purchase tobacco in Massachusetts is 21.

On a motion by Ms. Jagling seconded by Mr. Clark the Committee voted 8-0-0 to Recommend Article 7.

Article 14 Hometown Heroes Banner Project

Article 14 is a petitioned article by Mr. Kevin Fondas, et al. to raise and appropriate \$20,000 which will cover the cost of Hometown Hero Banners for the 43 Armed Services members from Hudson that were killed in action. Remaining funds will support families needing financial assistance to purchase a banner for a veteran. Banner cost to families will be \$200. The article appears on the warrant as submitted by the petitioner and specifies that the funds will be Raised and Appropriated; i.e. taken from tax revenue. Mr. Gregory anticipates that sufficient funds will be available within the levy in FY24.

On a motion by Ms. Jagling seconded by Guy Beaudette the Committee voted 7-0-1 to Recommend Article 14.
