### **FY25 Hearings for Annual Town Meeting May 6, 2024**

The following Articles in *FY25 Annual Town Meeting Warrant* were discussed and voted by the Committee

Article clarification notes:

- Article 3: Hudson Public Schools - the Committee voted on the Town Appropriation to the HPS budget. HPS also receives revenue from State and Federal grants, School Choice tuitions and State education funding. This year's budget uses all remaining funds in the School Choice Surplus account resulting in a projected budget shortfall of \$4,592,680 in FY26.
- Article 5: Capital Budget
  - Modular classrooms are needed in Mulready at a projected cost of \$480,000. Mulready and Farley schools are low on available space.
