PARK COMMISSION MEETING MINUTES Wednesday, October 21, 2020 Via REMOTE ZOOM at 7:15pm

Pursuant to Governor Baker's March 12, 2020 Order Suspending Certain Provisions of the Open Meeting Law, G.L. c. 30A, §18, and the Governor's March 15, 2020 Order imposing strict limitation on the number of people that may gather in one place, this meeting of the Hudson Park Commission meeting will be conducted via remote participation to the greatest extent possible. 5. Director's Report:

A. Departmental Financial Update

Mr. Santos gave the commissioners a summary of current departmental account balances.

Mr. Santos informed the commissioners that the FY22 budget preparation packets had not yet been released however, he anticipated we would received FY22 budget guidance from the town's EA in the coming weeks.

6. New Business:

A. 15 Broad Street Demo & Impact to ARRT

Mr. Santos informed the commissioners that a portion of the ARRT between Broad and Washington Street would be closed effective October 20, 2020, due to the demo of the building located at 15 Broad street; stating further that the demo may take up to 3-4 weeks to complete.

B. Winter 2020-2021 Programming Outlook

Mr. Santos stated that Hudson Recreation has been in contact with the School Department and use of school buildings this winter is uncertain.

7. Old Business:

A. Centennial Beach Project Update

Mr. Santos shared his screen with the meeting guests, displaying the dedicated Centennial Beach Project page, located on the Hudson Recreation website, which listed all project updates and photos. Mr. Santos suggested the commissioners visit the site in the coming week to see the progress. Discussion followed and a date of Tuesday, October 27, 2020 at 10:30am was determined for the site visit.

8. Communications and/or Correspondence to be noted by Commissioners:

A. Mr. Bowen stated that he had seen some activity on social media from a resident who lived close to the beach, which suggested some residents may push to have the park commission consider limiting beach access to residents only in the future. Mr. Santos stated that he is planning on discussing beach access, fees and rules & regulations with the park commission over the winter months ahead of the 2021 opening. Mr. Santos stated that to date no one had reached out to him about this matter. However, if anyone does he'd ask them to put any requests in writing to the park commission for consideration.
