A. Impacts of potential new DPW Building on Recreation Department

Mr. Santos informed the Commission that he had a conversation with the Executive Assistant, in which he stated that should the proposed new DPW building be constructed, that he would be open to exploring the option of relocating Hudson Recreation into a small portion of the existing DPW office space, should space become available, thus freeing up some office space within Town Hall for other town departments that are currently tight on space.

B. Summer Seasonal Employment Update

Mr. Santos stated that the admin staff had already interviewed 26 applicants and there were still approximately 12 more interviews to be conducted. Also, that there were currently more applicants than available positions and that the department was ahead of schedule on the process of determining summer seasonal employees.

Mr. Chaves and Mr. Bowen each

commented stating that they had no issues with the plan. Mr. Santos stated that he was targeting May 2^{nd} for the in-person meeting but a location was still TBD.
