# PARK COMMISSION MEETING – MINUTES October 18, 2023 Via REMOTE ZOOM at 7:00pm

Pursuant to Governor Baker's March 12, 2020 Order Suspending Certain Provisions of the Open Meeting Law, G.L. c. 30A, §18, and the Governor's March 15, 2020 Order imposing strict limitation on the number of people that may gather in one place, this meeting of the Hudson Park Commission meeting will be conducted via remote participation to the greatest extent possible. #### 5. Director's Report:

A. Budget Update

Mr. Santos informed the commission that he was working on preparing the FY25 budget due to the EA's office on October 27, 2023. Additionally, Mr. Santos stated that he would work with the commission to schedule an additional meeting in the coming weeks to review the FY25 proposed budget.

B. Dog Park Planning Progress Update

Mr. Santos informed the commission that he and Assistant Director Dan Hannon had met with KZLA to relay the feedback received from the cemetery commission, as well as share the details of what had recently been discussed with the Park Commission. Mr. Santos stated that he requested KZLA prepare basic design schematics and corresponding cost estimates for a future dog park at both Farina Field and the Sauta Field complex; to be presented to the Park Commission at their meeting to be held on November 8, 2023. Mr. Santos concluded by stating that the deadline for the Stanton Foundation Dog Park Design Grant is in December 2023 and therefore it was imperative that the Park Commission select a location on the evening of November 8, 2023 in order to allow enough time to prepare a successful grant application.

C. REC Fest 2023 Recap

Mr. Santos stated that while event attendance seemed lower than in past years, he felt it was successful and event attendees seemed to enjoy themselves. Mr. Santos concluded saying that the event layout was modified from years past and it made for a more intimate community gathering; and many vendors commented, saying they were happier with the 2023 layout.

#### 6. New Business:

A. Park Commission to listen to feedback residents may have, relative to the installation of field lights on Cherry Street Field.

Note: Notification of the Park Commission meeting was sent to abutters within 300 feet of property After reading aloud, the agenda item, Mr. Roan stated that he would open the meeting to any public comment. Mr. Santos stated that there was no one on the call/in the meeting or zoom waiting room other than the commissioners and the recreation staff; the time was 7:08pm.

Mr. Santos then stated aloud the reason for the request to add lights (as submitted to the CPC) to the field, the results of the CPC meeting for use of funds (all members voted in favor), and the next step in approval of CPC funds (November Town Meeting, to be held on November 20, 2023).

Mr. Santos then stated that the Recreation Office had mailed out 25 individual notices of the Park Commission meeting, held that evening (October 18, 2023), which provided notification of said meeting, to abutters within 300 feet of Cherry Street Field.

Mr. Santos continued on stating he had been forwarded an email from a resident on Cherry St, through Mr. Bowen, who had some concerns with general parking along the road. Mr. Santos informed the Commissioners that he had suggested that Mr. Bowen ask the resident to reach out to ITC, as their comment was not related to the installation of field lights and street parking regulations were not under the purview of the Park Commission.

Mr. Santos then stated the time, 7:12pm, and verified once again that there was no one on the call/in the meeting or zoom waiting room.

Mr. Roan stated that as there was no one present, looking to provide comment on the installation of lights on the Cherry Street field, he would move to the next agenda item.
