### 1. Call to Order:

### 2. Minutes to be Approved:

(1) implement a temporary moratorium on Monday that would run from Feb. 7th to Feb. 28th and announce that the Board will be accepting letters of interest from March 1st to March 15<sup>th</sup>. Letters of interest should include all pertinent ownership information, address, reason for seeking the available license and any other information that will help the Select Board make a decision that will best serve the public need; (2) post a notice in the Community Advocate newspaper to run on Feb. 18th to solicit letters of interest; (3), at the March 28th meeting, the Board would review all letters of interest and invite one of the interested parties to formally apply for the license.

#### 10. Town Issues:

Mr. Lucy asked for an update from the Hudson Cultural Alliance regarding the Armory. They reported holding the Armory for two years would cost \$25,000 per year plus insurance which we know is \$28,831 annually. This is an annual cost of \$54,000. He asked how much cash has be deposited into their accounts since they last met with the Board and what their cash balance is. He went on to say note that when this was placed in the warrant to buy the Armory residents were told repeatedly that the state would not proceed to sell the Armory unless Town Meeting voted to buy it but the Town could walk away at any time before closing without reason. We can walk away from the closing if in our judgment the Hudson Cultural Alliance is unlikely to raise the \$1.5 to \$2 million they say they need to convert the armory to a cultural center in two years they stated it would take to so.
