2. **Minutes to be Approved:**

Present were Superintendent Ernie Houle, Principal Mark Hollick, Director of Business Operations Maria Silva and Hudson’s Representative William Charbonneau. Mr. Houle gave the Board a thorough review of his budget.

On a motion by Mr. Duplisea, seconded by Mr. Sadowski, the Board voted 4-0 to approve the requested amount of \$3,301,238 for the Assabet FY 2024 budget.

b) Select Board to consider approving FY 2024 budget adjustments.

Mr. Gregory explained to the Board that he had to make some budget adjustments due to the Governor's numbers. He asked that the Board revise the numbers for the school department (due to an increase in Chapter 70 funds) and also revise the Health Insurance line item.

On a motion by Mr. Sadowski, seconded by Mr. Quinn the Board voted 4-0 to approve the revised amount of \$43,305,304 for the FY2024 Hudson Public School's appropriation.

On a motion by Mr. Sadowski, seconded by Mr. Duplisea, the Board voted 4-0 to approve the revised amount of \$5,425,000 for the Health Insurance account for the FY 2024 Budget.
