**1. Petition 2022-06 – 1 Mildred Circle**

At this time the Board of Appeals will hear the request of American Tower Corporation on behalf of MetroPCS, to amend a Special Permit issued on March 12, 2009, to allow the installation of a wireless communications facility, pursuant to Section 5.9 of the Town of Hudson Protective Zoning By-Laws. The proposed amendment entails the installation of additional equipment on the existing cell tower. The subject property is located at **1 Mildred Circle** in the SB Single Family Zoning District, Assessors' Map 40 Parcel 74. The Board may consider any action deemed necessary relative to the subject petition.

**2. Petition 2022-07 – 6 Freeman Circle**

At this time the Board of Appeals will hear the request of Michael and Christina MacDonald, requesting a Special Permit to construct an inground swimming pool and associated fencing within the Floodplain/Wetland District pursuant to the provisions of Section 5.7.4.3 of the Town of Hudson Protective Zoning By-Laws. The subject property is located at **6 Freeman Circle** in the SA7 Residential Zoning District and within the Floodplain/Wetland District, Assessors' Map 72 Parcel 28. The Board may consider any action deemed necessary relative to the subject petition.
