Warrant Article 36 - In accordance with the provisions of M.G.L. Chapter 40A, Section 5, the Hudson Planning Board will hold a public hearing on April 7, 2020 at 7:00 p.m. in the Town Hall, 2<sup>nd</sup> floor at 78 Main Street in Hudson, Massachusetts on whether the Town will vote to amend the Zoning Protective By Laws to delete, in their entirety, the existing Zoning By-law, including the Zoning Map and substitute a new document entitled "Town of Hudson Protective Zoning By-laws" and new Zoning Maps.

New components have been added to the By-laws to not only enhance the user experience, but help the Building Commissioner with zoning enforcement issues, and reflect new land uses over the past 60 years. New components include the following:

- updated land-use definitions
- a solar by-law;
- a drive-through by-law;
- updated parking requirements by land-use;
- a table of land uses by zoning district;
- the consolidation of zoning districts;
- the digitization of the Zoning Maps and;
- clarity to the section on non-conforming uses and structures.
