Re: FY2024 Year-End Deficits

Attached to this memorandum is a spreadsheet showing current year (FY2024) deficits in various departmental operating budgets. To resolve these deficits, I am requesting that the Finance Committee recommend deleting "a sum of money" in Article 2 on the Annual Town Meeting Warrant and insert in its place "the sum of \$230,789" so that said sum may be transferred at Town Meeting from previously certified and available Free Cash.

As mentioned previously, year-end deficits in prior years have typically been resolved via the alternate method as allowed in G.L. Chapter 44, Section 33B which requires that both the Finance Committee and the Select Board approve transfers from department budgets where a surplus is anticipated by June 30th. My preference is to continue the new practice, established last year, to bring current-end deficits to Town Meeting to be resolved via Free Cash since Town Meeting is the legislative body which originally appropriated the operating budgets in which the deficits occur.
