## **Conservation Commission**

  - Correcting violations (unpermitted alterations)








## Importance of Buffer Zones

- Light Reaching Wetlands
- Temperature of Wetland
- Flow of Water to Wetland
- Erosion into Wetland





## MA Wetlands Protection Act

#### State law that protects

- Bordering Vegetated Wetlands
  - 100-foot Buffer Zone
- Bank
  - 100-foot Buffer Zone
- Land Under Water
- Riverfront Area
  - 200 feet
- Floodplain



## Why a Bylaw?

- Increased development
   Buffer Zone is disappearing
   Wetlands are shrinking
- Unprotected resources
- Limited Enforcement ability

Note that almost 200 municipalities in MA feel that the state Wetlands Protection Act does not provide enough protection and have adopted Bylaws, including many of our neighbors.

## What the Bylaw will do

- Improve Protection
  - 25-foot No Disturb Zone



- Protection for isolated wetlands, small ponds, vernal pools
- Consideration of cumulative impacts, climate change, biodiversity, and recreation
- Increase Enforcement Ability
  - Ability to fine
  - Ability to require bonds for large projects
  - Appeals go to Superior Court

## 25-Foot No Disturb Zone

No work or disturbance is allowed within 25 feet of a wetland or water body unless it meets an exemption or is granted a waiver.

Pre-existing activities or structures need not be discontinued or removed.

Docks, retaining walls and other water related projects are exempt and may be permitted as in the past.

Exemptions for other minor activities also apply.

NOTE: Hudson currently has a 25-foot No Disturb Policy. This will turn it into law.

### What you can do in the No Disturb Zone

- Recreational activities (note that the Bylaw includes Recreation as a protected wetlands function)
- Maintain existing structures
- Maintain existing lawn and vegetation
- Plant new vegetation



### What you can't do in the No Disturb Zone

- Add new pavement or build a new permanent structure closer than existing pavement or structures
- Clear existing natural vegetation
- Use pesticides or fertilizers
  - NOTE: A waiver may be granted for work judged not to negatively impact the functions or values protected by the Bylaw, for which there is no good alternative.



## What the Bylaw won't do

- Impact existing conditions or structures
- Allow the Commission to add more restrictions through Regulations
- Add local filing fees
- Allow trespass on private property



#### New Development

- The bylaw **will not** prevent new development
- It will help ensure new development is done in an **environmentally-friendly** way





## **Section 1: Purpose**

#### Functions and values that are protected:

#### **Current State Law**

- Public or private water supply
- Groundwater
- Flood control
- Storm damage prevention
- Prevention of pollution
- Protection of fisheries and shell fisheries
- Protection of wildlife habitat

#### New in Bylaw

- Erosion and sedimentation control
- Water quality
- Rare species habitat including rare plant species
- Agriculture
- Aquaculture
- Biodiversity
- Impacts from climate change
- Recreation

## Section 3: Jurisdiction

#### **Current State Law**

- Any bank or freshwater wetland bordering on any creek, river, stream, pond (>10,000 sq ft), or lake
- 100-foot Buffer Zone to above if it impacts Resource Area
- Land under above waterbodies
- Land subject to flooding
- Riverfront Area (200 feet)

#### New in Bylaw

- Any bank or freshwater wetland whether or not it abuts surface waters
- Vernal pools, lakes, ponds of any size, streams, brooks, creeks, rivers
- 100-foot Buffer Zone to above
- 25-foot No Disturb Zone

### Section 4: Exemptions and Exceptions

- Many exemptions in Wetlands Protection Act also apply to Bylaw (agricultural usage, public utilities, emergency projects, certain minor activities in the Buffer Zone or Riverfront Area)
- Allows for additional exemptions in Regulations



## **Exempt Minor Activities**

- Routine mowing
- Maintaining existing buildings
- Unpaved walkways
- Maintaining existing stone walls
- Certain fencing
- Residential accessories such as sheds, decks, above-ground pools if 50 feet from wetland
- Planting non-invasive vegetation
- Pruning shrubs and trees

## Section 5: Administration

- Wetlands Protection Act application and plans may be accepted for the Bylaw and hearings combined
- Administrative approval for certain tree removal and fencing
- No new filing fees
- Waiver requests under certain conditions



## Section 6: Regulations

- Clarify implementation of the Bylaw
- Require Public Notice and Public Hearing before passage
- Cannot be inconsistent with the Bylaw



## Section 9: Enforcement

Establishes ability to fine for violations of the Bylaw or regulations, permits or administrative orders issued under the Bylaw:

- \$100 for the first offense
- \$200 for the second offense
- \$300 for the third and subsequent offenses





### Conclusion
